FISCAL IMPACT SUMMARY: Cost for ACAMS maintenance was approved in the 2019-2020 budget and will be included in each corresponding budget year.			
BACKGROUND: In direct support of the Ontario International Airport's Airport Security Program (ASP) the ACAMS, to include associated hardware and software, is an access control program consisting of multiple systems and subsystems implemented to effectively manage access control in accordance with TSA Regulations, to include the requirements of 49 Code of Federal Regulations §1542.207(a)(1)-(3).			
Given the mission critical importance of the current ACAMS, which is dated and approaching end of life staff recommends the ACAMS be replaced with the most current, commercially available, system.

PROCUREMENT: The OIAA conducted a request for proposals (RFP) selection process and received three responses on January 9, 2020. The qualified firms were reviewed by a panel who determined Birdi Systems, Inc. to be the most responsive firm.

CEQA COMPLIANCE AND LAND USE APPROVALS: The proposed staffing services decision is not a "project" under CEQA and does not require environmental review. To the extent the staffing services decision could be deemed a "project" for purposes of CEQA, it would be Categorically Exempt (Class 1) from the provisions of CEQA pursuant to (1) CEQA Guidelines section 15309 for project inspection services, (2) CEQA Guidelines section 15301 for the operations, repair, maintenance, permitting, or minor alteration of existing structures or facilities involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination, and CEQA Guidelines section 15303 for new construction, installation or conversion of a limited number of small structures, facilities or equipment.

STAFFING IMPACT (# OF POSITIONS): The proposed agreement will not impact staffing.

IMPACT ON OPERATIONS: ACAMS is a critical airport system and no unscheduled downtime is anticipated at any time for any purposes.

SCHEDULE: The contract will be executed upon Commission approval.

RELEVANT STRATEGIC OBJECTIVE: Develop Airport-Related Business.

RECOMMENDED ACTION(S): That the Ontario International Airport Authority (OIAA)

- 1. Adopt a resolution reaffirming the statutory authority of the San Bernardino County Transportation Authority (SBCTA) as the sole transportation planning agency in San Bernardino County and administrator of Measure I sales tax funds; and
- 2. Approve attached letters of opposition of SB 1390 and AB 2011 and direct staff to promptly send letters to Senator Portantino and Assembly Member Holden.

FISCAL IMPACT SUMMARY: None.

BACKGROUND: SB 1390, introduced by Senator Portantino in February 2020 and AB 2011, introduced by Assembly Member Holden in January 2020 are efforts to create an authority for the purposes of awarding and overseeing all design and construction contracts for completion of an extension of the Metro Gold Line light rail project from the City of Montclair to the Ontario International Airport. The bill would require a 7-member committee, including a member from the Los Angeles County Metropolitan Transportation Authority, be created to determine the use of Measure I funds paid by San Bernardino County residents.

The creation of a new authority as contemplated by SB1390 and AB2011 is redundant in its efforts as the OIAA works collaboratively with the SBCTA to prioritize transportation projects and to work towards bringing rail access to the Ontario International Airport. Additionally, such efforts would divert critical resources from the region and strip authority from local policy makers. Accordingly, OIAA opposes any effort in SB 1390 and AB 2011 to remove or infringe upon SBTCA's obligation and authority to fund, plan, construct, and deliver major transportation projects in San Bernardino.

OIAA takes the position that local control of the Measure I funds is vital and opposes the creation of a new authority that would divert funding resources away from local control. In 2016, the San Bernardino Associated Governments sponsored Senate Bill 1305 (Morrell) to consolidate the four transportation entities; Transportation Commission, Service Authority for Freeway Emergencies, Congestion Management Agency and the County Transportation Authority into the San Bernardino County Transportation Authority (SBCTA). Since then, the SBCTA administers the Measure I funds, and has a detailed list of projects approved by the voters. OIAA supports SBTCA's efforts in planning and constructing transportation projects while maintaining fiduciary responsibility for managing over approved Measure I sales tax dollars.

- **WHEREAS**, the San Bernardino Associated Governments (SANBAG) was formed in 1973 as a sub-regional council of governments under a Joint Powers Agreement, and today SANBAG includes the County Board of Supervisors and twenty-four cities and other agencies in San Bernardino County, including the City of Ontario and the Ontario International Airport Authority;
- **WHEREAS**, SANBAG's responsibilities grew to include the roles of the County Transportation Commission, Service Authority for Freeway Emergencies, Congestion Management Agency, and the County Transportation Authority;
- **WHEREAS**, in 2016, Senate Bill 1305 (Morrell) consolidated the four transportation entities into the San Bernardino County Transportation Authority (SBCTA);
- **WHEREAS**, in 1989, San Bernardino County voters passed Measure I, a countywide ½ cent sales and use tax to fund transportation projects within the County from 1990 to 2010:
- **WHEREAS**, Measure I identifies the SBCTA as the administrator of Measure I funds;
- **WHEREAS**, in 2004 County voters passed a renewal of Measure I, extending the transportation project funding from 2010 to 2040;
- **WHEREAS**, the 2004 renewal of Measure I contained a detailed list of projects approved by the voters;
- **WHEREAS**, the Ontario International Airport Authority supports rail transportation to and from the Ontario International Airport;
- **WHEREAS**, the Ontario International Airport Authority is represented on the SBCTA Board of Directors through a duly appointed member from the Ontario City Council and has a voice on transportation planning efforts in the County;
- **WHEREAS**, the Ontario International Airport Authority supports local control funding, construction planning, and delivery of major transportation projects in the County;

WHEREAS, also through the SBCTA Board of Directors, the Ontario International Airport Authority works cooperatively with SBCTA member jurisdictions to collaboratively prioritize transportation projects and associated funding;

NOW, THEREFORE BE IT RESOLVED by the Ontario International Airport Authority, that it recognizes SBCTA's responsibility as the sole transportation planning agency and the voter approved stewards of transportation funding in San Bernardino County;

BE IT FURTHER RESOLVED, that the Ontario International Airport Authority opposes any effort in Senate Bill1390 and AB2011 to remove or infringe upon SBCTA's obligation and authority to fund, plan, construct, and deliver major transportation projects in San Bernardino County.
